



Cottage Life Subscription Contest Terms & Conditions

2. Contest is open until 11:59 p.m. EST on July 31, 2007. Contest is open to any individual over the age of majority and a legal resident of Canada.

Entries must be received by no later than 11:59 p.m. (Eastern Standard time) on July 31, 2007 to be eligible for the draw.
